Congressman Castro Applauds Long-Sought Renaming of Fort Hood for General

Richard E. Cavazos

Congressman Joaquin Castro (TX-20) released the following statement applauding the decision to rename Fort Hood for Richard E. Cavazos, a military hero who made history in 1982 as the first Hispanic four-star general in the U.S. Army:

“I’m grateful that The Naming Commission has recommended renaming Fort Hood to honor General Richard E. Cavazos, a history-making general who fought bravely and inspired generations of young servicemembers to follow in his footsteps,” said Congressman Castro. “Throughout our nation’s history, Hispanic and Latino servicemembers have served with valor and distinction — despite, at times, facing discrimination at home and abroad. These courageous men and women have played essential roles in our most defining battles and protected freedom across the world. I hope the new Fort Cavazos will be a welcoming community that our servicemembers and military families are proud to call their home.”

In 2020, Congressman Castro and a bipartisan coalition of members of Congress voted to establish The Naming Commission, a commission tasked with developing a plan to rename

military assets that commemorate Confederate leaders. Fort Hood is currently named for John Bell Hood, a confederate military leader and white supremacist who was relieved of his rank after disastrous defeats during the last year of the Civil War.

The Naming Commission received more than 34,000 public suggestions for new installation names that would better reflect the courage and strength of America’s Armed Forces. On April 12, 2021, Congressman Castro and members of the Congressional Hispanic Caucus (CHC) wrote to Secretary of Defense Lloyd Austin and The Naming Commission to highlight the importance of Latino representation in the names of military assets. The CHC letter suggested the names of several prominent Hispanic military leaders for consideration, including General Cavazos, Master Sergeant Roy Benavidez, Staff Sergeant Macario Garcia, Private Marcelino Serna, and Technician 4th Grade Carmen Contreras-Bozak.

Richard E. Cavazos was born on January 31, 1929 in Kingsville, Texas. A star football player, he overcame racism and educational inequality to enroll in Texas Technological College (now

Texas Tech), where he committed to serve his country through the Reserve Officers’ Training Corp. In 1951, he was commissioned into the Army and later deployed to Korea, where the bilingual Cavazos was welcomed as the leader of the Borinqueneers, a regiment of mostly Spanish-speaking Puerto Rican soldiers. In Korea, his heroism earned him the Silver Star and the Distinguished Service Cross. After his service in Korea, Cavazos served in Vietnam, where was beloved as a commander who would fight side-by-side with his troops. In Korea, Cavazos earned a second Distinguished Service Cross. Beyond his service on the battlefield, Cavazos was a mentor to countless servicemembers, including future Secretary of State Colin Powell. In the final decade of his military service, Cavazos made history as the first Hispanic brigadier general and the first Hispanic four-star general in U.S. history. After retiring from the Army in 1984, Cavazos continued to be a mentor and role model for young military leaders. He died in San Antonio, Texas at the age of 88 and was buried at Fort Sam Houston National Cemetery.

Peter J. Holt, presidente de la mesa directiva del equipo Spurs de San Antonio y de la empresa Spurs Sports and Entertainment (SS&E), con cierta confianza en boletín oficial informativo hizo incapie, sobre la seguridad del pentacampeón club seguirá en la región de El Álamo "Por Vida".

La excelencia trayectoria de los Spurs se debe al incansable trabajo que por 26 años ha venido realizando su entrenador en jefe Gregg Popovich quién logró establecer marca mundial en el deporte profesional clasificando a San Antonio durante 22 temporadas consecutivas en los playoffs de la NBA.


Hasta la fecha Spurs sigue comandando esa marca seguido por los Patriots de New England con 10 en la NFL.






Not News - San Antonio Fails to Avert Baby Formula Crisis

When the COVID-19 pandemic hit, and San Antonians needed its health department the most, Metro Health was a hot mess. Beginning March 2019, the department saw numerous leadership changes. Most of the turmoil happened during the critical periods of the pandemic. For two years COVID raged, Metro Health was rudderless; for the biggest poor city in the country facing its biggest health crisis, San Antonio leaders couldn't have failed the community more.

This is why it's no surprise city leaders are asleep at the wheel again as parents in the Alamo city are struggling the most in the U.S. to get the formula their infants need. This emergency has only been 5 months in the making for the city to get ahead, but instead San Antonio is in the national headlines for all the wrong reasons.

Only after a world-wide pandemic, snowmageddon and the longest food-bank lines in the country could city officials no longer hide the extent of San Antonio's poverty. Even City Manager Mini-Sculley admitted "We're reinvesting in our public health," in the city budget which means we've been spending money developing downtown for the last decade. He said that "people may notice more of a renewed investment in public health," which

means we're clueless because it's been nada for the thousands of mothers panicking to find baby formula. The situation begs the question, how can a city with a record \$3.1 billion budget be so unobservant, far-removed, ill-prepared and incapable of providing a smidgeon of relief to this current situation?

It's likely the city selected the wrong health director, again. For a city that purports to be a leader in the medical sector, it's a travesty San Antonio could not produce a home grown candidate. This inability speaks volumes about our city government's hiring prejudices. There are many positions within the City of San Antonio that should be headed by leaders who are born and reared in Bexar County, and a city's health director is probably among the most important. It's called community health for a reason and San Antonio's newest can't even speak Spanish if we are going to be woke about qualifications that matter for a city with more than half a million and more arriving everyday.

But this is what happens when you have the wrong leaders - mammoth-sized ice-burges fall through cracks even when they've been approaching for months at a time; not to mention you won't be finding a Mexican-American heading up Fulton County's (Atlanta) Board of Health if we are to

be mega-woke and honest about the current city agenda.

San Antonio also prefers to invest in its own inept bureaucracy than push investment into the plethora of community organizations who are actually on the front lines doing the work. It's probably easier for the city to dole out a developer enticement package than get an emergency crisis response grant to Any Baby Can for example. Perhaps one day the city will appreciate and understand the assistance these organizations provide to the #1 big poor city. Meanwhile, the City Hall b-team believes it can do it all and do it better.

We know San Antonio cannot take care of its current population. The situation is getting worse with an even bigger population and the city's answer is to build more housing. This is exactly why a \$3.1 billion city budget can't get a bone to the poorest mothers in the country during this crisis and probably the next; and that's what's most scary about the City's renewed investment in public health. What we can see already, it's going to be a mega hot mess.

Reps. Castro, Espaillat Lead Push for Biden Administration to Expand Temporary Protected Status for Migrants from Guatemala, El Salvador, Honduras, and Nicaragua

Reps. Joaquin Castro (TX-20) and Adriano Espaillat (NY-13) led a bipartisan letter to President Biden, Secretary of Homeland Security Alejandro Mayorkas, and Secretary of State Antony Blinken urging the administration to expand Temporary Protected Status protections for migrants from Guatemala, El Salvador, Honduras, and Nicaragua.

Despite the ongoing humanitarian crises in Guatemala, El Salvador, Honduras, and Nicaragua, citizens of these nations who flee to the United States without legal status face an uphill battle to remain in the country. If detained, they can face deportation back to countries beset by food insecurity, political conflict, and economic instability — challenges that have been exacerbated by the COVID-19 pandemic and twin hurricanes that hit the region in November 2020. An estimated 1.5 million migrants in the United States would benefit from extending TPS to Guatemala, El Salvador, Honduras, and Nicaragua.

Today's letter is endorsed by United We Dream, Immigration Hub, Church Worldwide Services, Kids in Need of Defense (KIND), Latin America Working Group (LAWG), Washington Office on Latin America (WOLA), and Women's Refugee Commission (WRC).

Dear President Biden, Secretary Mayorkas, and Secretary Blinken,

We write to urgently request your administration expand Temporary Protected Status protections for migrants from Guatemala, El Salvador, Honduras, and Nicaragua. We have watched with concern the worsening humanitarian crisis in Central American countries in the aftermath of Hurricanes Eta and Iota in 2020, continued severe drought, and the COVID-19 pandemic. We believe designating Guatemala and redesignating El Salvador, Honduras, and Nicaragua for Temporary Protected Status (TPS) would go a long way in assisting those communities in the United States and enable them to better support their families back home.

The pressures of the November 2020 hurricanes compounded with the long-term effects of climate change and the COVID-19 pandemic have worsened food insecurity and violence in countries in Central America. Hurricanes Eta and Iota left over 9.3 million people, including 3.5 million children, affected and forced to leave their home communities. The hurricanes also left long-lasting damage by destroying key healthcare, education, and other infrastructure essential to everyday lives. Almost a year later, millions in Honduras, Guatemala, Nicaragua, and El Salvador still lacked access to humanitarian assistance, housing, and basic services.

The COVID-19 pandemic and the hurricanes interrupted the crucial flow of remittances to Guatemala, Honduras, El Salvador, and Nicaragua, which served a crucial role in supporting the region's economic recovery. The Famine Early Warning Systems Network (FEWS NET) estimates areas affected by the two hurricanes, as well as the Dry Corridor in Honduras and Guatemala, will remain in crisis levels of food insecurity through at least May 2022. Over 8 million people went hungry in 2021, quadrupling from 2018, and these numbers will continue to rise as we see the increased effects of climate change on agriculture outputs, security, and economic integration. As your administration has recognized climate change as a key contributor to migration, these designations would support the administration's efforts to address the root causes of migration as communities in Central America have weathered the brunt of climate change's effects including consecutive years of drought and extreme weather events.

The changing political dynamics in these countries also underscore the difficulties individuals face in returning home. For example, the crackdown on civil society, journalists, and other dissidents in Nicaragua over the last few years has worsened to the point where return for many Nicaraguans means imprisonment or other forms of punishment. Similar situations have emerged over the last year in El Salvador and Guatemala. The U.S. Government must respond to these developments by adding these TPS designations to the larger landscape of assistance for Central American countries and as part of the administration's effort to curb corruption, impunity, and

violence in the region.

We believe that conditions on the ground in Guatemala, Honduras, El Salvador, and Nicaragua constitute "extraordinary and temporary conditions" that prevent nationals from safely returning. These countries have been dealing with the aftermath of such events for years and as conditions continue to worsen and new challenges arise, the United States should provide temporary protection and refuge. Furthermore, these designations would provide the U.S. government with an important tool to address root causes of migration from Central American countries by helping increase the flow of remittances and supporting government efforts to address in-country conditions without the additional tax of a large influx of individuals forced to return home. The designation would likely protect nearly 1.5 million migrants currently in the United States, providing immediate relief to these individuals and their families. We ask that these TPS designations be paired with a robust and comprehensive messaging campaign that offers clear instructions regarding eligibility and application procedures, as to prevent confusion and mass migration that occurred after the May 2021 Haiti TPS designation.

It is our view that Guatemala, El Salvador, Honduras, and Nicaragua meet the circumstances and standards for TPS. We look forward to continuing to support the efforts from your administration to address the root causes of migration in Central America in a holistic manner, including by taking this important step to uphold humanitarian protections and safeguard U.S. national security interests. Thank you for your consideration.

Commissioner Calvert Highlights Plan

Tommy Calvert, the County Commissioner that represents the AT&T Center where the Spurs Play, had extremely positive talks with Spurs management over the last week. Calvert requested Derrick Howard, Executive Director of the Coliseum/AT&T Center grounds, give an update to the Bexar County Commissioners Court about the recent collaboration between the County, Spurs, and Rodeo on improvements to the Coliseum on Tuesday, May 17, 2022. Calvert believes that voter support of future improvements to the arena, which by the time the lease is up in ten years; would be about 30 years old, would need to include something for the average working person.

“Building parking garages with housing on top that 70 percent of the working people can afford would make people feel like they have a shot at receiving some benefit

from their own taxpayer dollars for arena improvements,” explained Commissioner Calvert. He continued, “The Venue

Tax Law that was written by Senator Van de Putte and Rep. McClendon and other tools at the County’s disposal gives us the freedom to deliver major benefits to the average working person while finally fulfilling the County’s role in economic development around the arena—a promise the County never fulfilled.”

As part of the Commissioner’s vision, Calvert believes offering the Spurs the first opportunity to have equity in the housing, restaurants, office space, retail, and entertainment businesses, also can help provide additional revenue to the team and make the asking price for an out of town buyer more expensive—helping to keep the Spurs in San Antonio.

Commissioner Calvert has allocated \$250,000 for consul-

tants to develop plans for restaurants, entertainment venues, housing, and other potential revenue streams the Spurs and the County can share along with the Rodeo.

Calvert has worked with Halff Engineers on a concept called “River East” that uses an 80 million dollar drainage tunnel to take property along Salado Creek near the AT&T Center out of the flood plain. This plan would also put the City’s Willow Springs Golf Course into play for development with the County, City, and the Spurs for real estate development of housing, hotels, restaurants, office space, and more; pending voter approval or state legislative action to develop the golf course. Calvert has encouraged City officials to use zoning powers to prevent displacement of existing residents along with increased affordable housing plans from the County.
